Constitutional law – principles of electoral law the aim of the course is to familiarize students with the theoretical foundations of the electoral system in force on the basis of the Constitution of the Republic of Poland of April 2, 1997 and the Electoral Code of January 5, 2011 by presenting the assumptions of today's electoral systems, discussing the basic principles of electoral law and their guarantees, and analyzing regulations constitutional, statutory and sub-statutory matters relating to the mode of appointing public authorities.

Legal ethics – the aim of the course is to discuss the ethical attitudes of lawyers, bailiffs, prosecutors, judges, and legal advisers.

Obligations in civil law – The aim of the course is to provide students with knowledge and develop skills related to the concept of obligations both in general and in detail, including with the concept of liability, benefit, damage, creditor, debtor and individual types of liabilities, such as a contract of sale, lease, tenancy, etc.

Criminal law, general part – crime – the aim of the course is to present the legal status in the field of criminal law, the functions of criminal law, the principles of criminal liability and the science of crime.

Criminal proceedings - general principles – the aim of the course is to present the legal status in the field of criminal proceedings. Discussion of the indicated issues will allow students to assimilate the basic principles of criminal procedure with particular emphasis on preparatory proceedings. Acquiring theoretical knowledge based on and strengthened by knowledge of legal norms, in particular the regulations of the Code of Criminal Procedure, will prepare students to learn about the next stages of criminal proceedings. This will allow the student to obtain comprehensive knowledge in the area of criminal proceedings and will enable them to gain the ability to use this knowledge in their future professional work, as well as in further education.

Constitutional law – basic principles – the aim of the course is to familiarize students with the theoretical foundations of the constitutional catalog of systemic principles by analyzing and commenting on the relevant standards of the Basic Law, interpreting the provisions of constitutional acts, specifying the institutions of the political, social and economic system of the state, reviewing court and tribunal jurisprudence and presenting the position of the doctrine of law constitutional.

The system of state organs in the Constitution – the aim of the course is to discuss the institution of the constitutional system of state authorities, presenting, through the analysis of the current legal status, the positions of the doctrine of constitutional law and the jurisprudence of the Supreme Court and the Constitutional Court.

Civil law – general part and property law – the aim of the course is to present the basic issues in the field of civil law. Students learn the basic issues of civil law relationships, civil law entities, the rules of concluding contracts, legal transactions and defects of declarations of will, as well as issues related to property rights and limited rights in rem. During the classes, students prepare solutions to civil law cases.

Family and inheritance law – the aim of the course is to present issues in the field of family and inheritance law. During the classes, students learn the basic issues concerning, among others, dissolution of marriage, separation, matrimonial property regimes, deprivation and limitation of parental authority or succession by the testamentary disposition.

Criminal law, general part – punishment – the aim of the course is to present the legal status in the field of criminal law in the field of punishment. The subject is a component and continuation of the criminal law issues, which in the third semester focused on the issues of crime science.
